License

Tomasz Huczek grants you a revocable, non-exclusive, non-transferable, limited license to download, install and use the Application solely for your personal or commercial purposes strictly in accordance with the terms of this Agreement.

not have any liability or responsibility to you or any other person or entity for any Third-Party Services.

Term and Termination

This Agreement shall remain in effect until terminated by you or Tomasz Huczek.

Tomasz Huczek may, in its sole discretion, at any time and for any or no reason, suspend or terminate this Agreement with or without prior notice.

This Agreement will terminate immediately, without prior notice from Tomasz Huczek, in the event that you fail to comply with any provision of this Agreement. You may also terminate this Agreement by deleting the Application and all copies thereof from your mobile device or from your computer.

Upon termination of this Agreement, you shall cease all use of the Application and delete all copies of the Application from your mobile device or from your computer.

Termination of this Agreement will not limit any of Tomasz Huczek's rights or remedies at law or in equity in case of breach by you (during the term of this Agreement) of any of your obligations under the present Agreement.

Amendments to this Agreement
